WHEREAS, above named requests to have the below mentioned items offered for sale by Bella Bag LLC, and WHEREAS, Bella Bag LLC wishes to represent the above named under the said terms of the agreement, BOTH PARTIES AGREE:

1. Term This agreement shall have a term of one hundred-twenty (120) days and may be terminated by either party giving fourtneer (14) business days written notice. Only if the agreement is terminated early by the consignor, Bella Bag will return to the consignor any unsold merchandise at the consignor's expense. Agreements terminated early incur a \$35 fee each.

2. Process Upon receipt, Bella Bag will take all necessary steps to sell items at appropriate pricing. Items will be sold on Bella Bag's owned personal venues.

3. Sale Price Bella Bag will determine prices for all bags consigned. If a specific minimum price is required, the Consignor must state the requested listed in this Agreement below. Any specific minimum pricing listings not met will incur a \$20 fee at the close of 120 days.

4. Reductions If any item has been available for over 90 days, may be reduced by 10%.

5. Authenticity Both Bella Bag and the Consignor attests to the authenticity of all agreed upon items. Items deemed to be counterfeits

will either be returned to Consignor for a \$25 authentication fee plus return shipping fees, or discarded.

6. Shipments If consignor is unable to drop off consignments at Bella Bag offices, the agreed upon item/s may be shipped to BELLA BAG, 700 S. Harbour Island Blvd. #407, Tampa, FL 33602. International consignors will cover customs fees and shipping fees.

7. Commissions Bella Bag agrees to pay the consignor 70% of the net sale price of all items placed for sale with Bella Bag and listed below and/or in any addendum.

8. Payment Consignors are paid by check or paypal after their items are sold. Bella Bag will provide an invoice to the Consignors. Payments will be sent out on either the 15th or 30th of each month.

9. Loss or Damage Consignor will ensure that consignment items are insured from all risks until agreed upon items are delivered to Bella Bag at the contracted drop off or shipping address. Upon delivery, Bella Bag will be fully responsible for said items until confirmed delivery to respective buyers.

10. Ownership Consignor attests to have legal title to and are in legal possession of all items that they have contracted Bella Bag to sell.

11. Revision Both parties understand all statements included in this agreement. This agreement may not be revised without the written consent of both parties.
